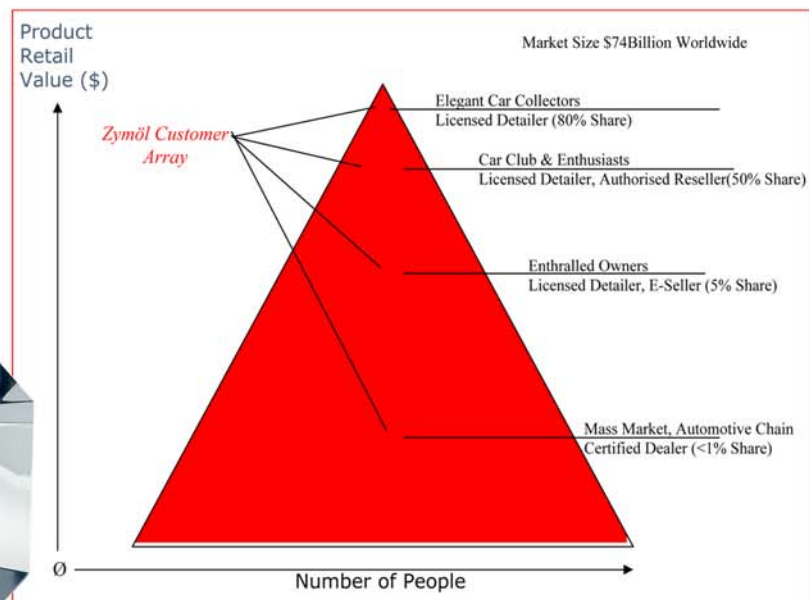

Zymöl Enterprises, Inc. ("Zymöl") is pleased to select _____ as a Certified Dealer (Dealer) subject to the following terms and conditions set forth herein.

1. DEALER'S INVENTORY ACTIVITIES

Dealer is requested to maintain adequate Products inventory for servicing in _____. Dealer represents that it has the skill, experience, and resources to carry out its obligations under this Agreement. Dealer must, at all times, conduct its business in a dignified and legal manner.

2. TRADE NAMES, TRADE MARKS, AND TRADE SECRETS

(a) Dealer expressly acknowledges and agrees that it will not have or acquire any rights in or to the trademark or trade name Zymöl or the Zymöl Logo or other trademarks ("Trademarks") used or adopted in connection with any of the Products, whether or not such trade marks or trade names are registered. Dealer shall not alter, remove or cover over any of the Trademarks or any trade names or symbols applied by Zymöl to the Products. Dealer shall notify Zymöl of all potential infringements of the Trademarks and assist Zymöl in the enforcement of its trademark rights. Dealer further undertakes that it will not at any time, during the term of this Agreement or thereafter, use such trademarks or trade names or any trademarks or trade names similar thereto or any colourable imitations thereof, whether in English or otherwise, in connection with its own business. Dealer shall not, during or after the term of this Agreement, use, register or obtain in its own or in any other name, the corporate name or domain name "Zymöl" or a translation similar thereto or a corporate name or domain name which contains the word "Zymöl" or a translation similar thereto without express written permission from Zymöl. These provisions shall survive termination of this Agreement for whatever reason. Upon termination of this Agreement, Dealer shall immediately cease to use all Trademarks.

(b) Dealer acknowledges that confidential and proprietary information developed or acquired by or licensed to Zymöl ("Information") may be disclosed to it during the performance of this Agreement. Dealer must take all reasonable precautions necessary to safeguard the confidentiality of the Information, including, without limitation, those taken by Dealer to protect its own confidential information; and those that Zymöl may reasonably request from time to time. Dealer will not allow the removal or defacement of any confidentiality or proprietary notice placed on any Information. The placement of copyright notices on any item of Information will not constitute publication or otherwise impair their confidential nature. Dealer will use the Information exclusively to perform its obligations pursuant to this Agreement. Dealer will not copy, reproduce, translate, modify and/or adapt the Information, except as may be specifically authorised by Zymöl in writing, and then only under terms and conditions specified by Zymöl. Dealer acknowledges that any unauthorised use or disclosure of any item of Information may cause irreparable damage to Zymöl. If an unauthorised use or disclosure occurs, Dealer will promptly notify Zymöl and take, at Dealer's expense, all steps which are necessary to recover the Information and to prevent its subsequent unauthorised use or dissemination, including availing itself of actions for seizure and injunctive relief.

(c) Dealer can display the "Zymöl Authorised Dealer" logo on any and all published material including but not limited to electronic published material. Dealer may only use product images and marketing collaterals available from Zymöl. Dealer understands this is a non-exclusive agreement.

3. MANUFACTURER'S RECOMMENDED CUSTOMER SERVICE

Manufacturer's Recommended Customer Service is a policy adopted by Zymöl in order to encourage Official Dealers to protect their customer base and to protect the Zymöl reputation of superior technology and quality products when selling Zymöl products. It is a Zymöl unilateral policy to cease supplying any and all products to any Dealer whose customer support for the sale of a product;

- a) Is less than 100% customer satisfaction –or-
- b) Refuses to supply the customer in proper timeframe.

4. MISCELLANEOUS

Either party upon 10 days prior written notice may terminate this Agreement. The obligations of Dealer set forth herein shall survive such termination. The parties agree that in the event of any dispute, Florida, USA law shall govern and venue shall be deemed proper in any court located in the state of Florida. Dealer agrees that, due to unique nature of the Products, the Trademarks and the Information, in addition to any other rights to which it may have, Zymöl shall be entitled to injunctive relief to enforce its rights hereunder.
